



## TERMS & CONDITIONS OF PARTICIPATION 2020-2021



Participation in ExpoFest Productions Inc. Event(s) is optional. By participating in the Event(s), or initiating intent to participate in the Event(s) (I.E. By submission of registration documents or payment on the Participant's behalf, from the club, gym, school, studio, individual, organization or association of which the Participant is a member), acceptance the following Terms and Conditions is legally assumed by all Participants and/or their Parents/Legal Guardians:

**RELEASE OF LIABILITY :** The Participant and/or the Parent/Legal Guardian releases BN #70982 9089 (ExpoFest Productions Inc.) as the hosting bodies and host venue(s) (virtual/online or on location which may include a school, university, arena, convention centre, etc.), any and all sponsors of the Event(s), all vendors at the Event(s) (collectively the "Releasees") and all of the directors, officers, employees, sub-contractors, agents or representatives of each of the Releasees from any and all liability whatsoever from any claim, demand, action or cause of action of any kind arising from any damages, illness, injuries of any kind or death of the participant, as a result of or caused directly or indirectly by the Participant attending, participating or competing in the Event(s).

**USE OF IMAGES OR RECORDINGS FOR/OFF THE EVENT(S) :** The Participant and/or the Parent/Legal Guardian hereby transfers and assigns to ExpoFest Productions Inc. and its successors, the exclusive royalty free right to make recordings or use submitting recordings, and utilize the Participant's image and/or voice for the purposes of ExpoFest Productions Inc. for the Event(s), the worldwide virtual (online) event(s), for any future Event(s), for advertising and promotion in general or for any other commercial purpose. The Participant and/or the Parent/Legal Guardian waives any right to monitor, inspect or approve any such recordings or the use of any such recordings. As the Virtual Series is open to all countries for participation it will not be geo-blocked.

**REFUNDS :** Refunds will be issued if the 2020-2021 season online event is cancelled by ExpoFest Productions Inc. Should an event be cancelled, the program will be reimbursed 100% of the registration fees paid for that specific event calculated by the total registration fees paid divided by the total number of events registered for. ExpoFest Productions Inc. reserves the right to re-schedule or postpone events if necessary. Failure of program to send in video for any reason will not result in refund.

**MEDICAL RELEASE :** The participant and/or the Parent/Legal Guardian certifies that the participant does not suffer from any physical disability, sickness, or medical condition which would pose risk to the Participant or others while attending, participating or competing in any ExpoFest Productions Inc. Event(s) in the 2020-2021 season and understands that ExpoFest Productions, Inc. is/are relying on this certification. The Parent/Legal Guardian acknowledges that there is a risk to the Participant of sustaining an injury or sickness (minor, serious, catastrophic or fatal) by reason of attending, participating or competing in the Event(s). The Parent/Legal Guardian, on his or her own behalf and on behalf of the Participant, hereby assume all responsibility for any such risk and releases Expofest Productions, Inc. as the hosting bodies, the host venue and any sponsors of the Event(s), from any claim, demand action of cause of any kind with respect to such injury. Notwithstanding that ExpoFest Productions Inc. has no obligation to do so; the Parent/Legal Guardian authorizes ExpoFest Productions Inc. to provide treatment for the Participant in the event of injury during a live in-person event. If no medical treatment is provided, or if the treatment is ineffective, ExpoFest Productions Inc. will not be liable in any way. The Parent/Legal Guardian shall be responsible for all costs of any such treatment and holds harmless, Expofest Productions, Inc. or its agents in this regard.
